Dear Sir,

With reference to your letter No. 8713/J.U.58, dated October 17, 1958 seeking clarification of the phrase 'for the purpose of admission to B.A. English only' in connection with the recognition of "Adeeb-i-Kamil" examination of your Institution, I am to inform you that this examination has been recognised by this University on par with the examinations of other Universities or Institutions enumerated under Ordinance G of Chapter XXXIV of the Calendar of this University and this Ordinance after the addition of 'Adeeb-i-Kamil' examination will read as follows:-

"6. A student who has (1) passed any of the following examinations- the Fazil Examination in Arabic or Kamil Examination in Persian conducted by the Education Department of the Uttar Pradesh, the Acharya Examination of the Government Sanskrit College of the Banaras Hindu University, the Dabir Kamil or Fazil examination of the Lucknow University, the Acharya examination of the Jaipur State, the Ratna Examination of the Hindi Sahitya Sammelan, the Shastri or Maulvi Fazil or Munshi Fazil Examination of the Panjab University, the Sarawati Examination of the Prayag Mahila Vidyapeeth, the Shastri Examination of the Government Sanskrit College, Banaras, Shastri Examination of the Banaras Hindu University, the Shastri and Acharya Examinations of the Lucknow University, the Adeeb-i-Kamil Examination of the Jamia-Urdu of Aligarh, and (2) has also passed the English the Intermediate Examination of the U.P. Board of High School and Intermediate

P.T.O.

Education will be eligible for admission to the University and after a regular course of study extending over two academic years will be eligible to appear at the U.A. Examination in no subject other than in English (compulsory and optional). If successful he will be granted a certificate of having passed the examination in English (compulsory and optional).

I hope the above will meet your query.
